

Technical rule no. 06 Rev. 01 PPA Bulletin Board

(pursuant to article 4 of the Regulation of Bulletin Board of long-term energy contracts from renewable sources)

1. Introduction

Article 10, paragraph 10.3, of the Regulation of Bulletin Board of long-term contracts for energy from renewable sources (hereinafter: Regulation) provides that GME publishes, in anonymous and aggregate form, on its website, as indicated in the Technical Rules:

- a) the data and information referred to in Article 26, paragraphs 26.1, 26.2 and 26.3, letter a) below, relating to the purchase and sale notices presented on the PPA BULLETIN BOARD;
- b) the data and information referred to in Article 29, paragraph 29.2, letters b), c), e), f), g), h) and i) and paragraph 29.3, letter a), relating to long-term contracts energy from renewable sources registered on the PPA BULLETIN BOARD.
- c) data and results of the electricity allocation procedures of the *energy release* section.

2. Data and information relating to the notices published on the PPA Bulletin Board

GME publishes on its website the data and information relating to the notices, selecting, from the minimum information indicated by the operators in the proposition of their notices, those which, made anonymous and aggregated, are most representative for the evaluation of the notices present on the PPA Bulletin Board of interested parties.

The data and summary information published with reference to the notices are updated on a daily basis, distinguishing between purchase and sale.

With regard to the notices presented on the PPA Bulletin Board, GME publishes on its website in aggregate anonymous form the number and total quantities covered by the notices broken down by:

- Purchase/sale
- Capacity (if a sale notice)
- Duration of the proposed contract

3. Data and information relating to contracts registered on the PPA Bulletin Board

GME publishes on its website the data and information relating to the registered contracts, selecting from the information indicated in Article 10, paragraph 10.3, letter b), of the Regulation,

those which, made anonymous and aggregated, are more representative than for the purpose of providing summary information on the evolution of the conclusion of long-term electricity purchase and sale contracts from renewable sources.

GME publishes, on a monthly basis, on its website in aggregate anonymous form the number and total quantities covered by the purchase and sale contracts registered on the PPA Bulletin Board broken down by:

- Capacity
- Duration of the proposed contract.

4. Data and information related to the assignment procedures on the PPA Bulletin Board

GME publishes on its website, in anonymous and aggregated form, at the same time as the communication of the results in accordance with the provisions of Technical Rule n. 05 of PPA Bulletin Board, for each assignment procedure carried out:

- the amount of electricity made available for sale by the GSE at the sale price;
- the sale price offered by the GSE;
- the total amount offered for purchase by the operators;
- the total amount of energy assigned;
- the number of assigned operators.
