Foreword

Article 12, para. 12.1 of the Integrated Text of the Electricity Market Rules (hereafter “Electricity Market Rules”) provides that a party intending to participate in the market must submit to GME: a market participation application in the format of Annex 1 to the Electricity Market Rules, together with the documentation indicated in Article 13 thereof; and a market participation agreement in the format of Annex 2 to the Electricity Market Rules.

Article 14, para. 14.1 provides that, after verifying the applicant’s fulfilment of the requirements and the validity of the documentation submitted in view of participating in the market, GME shall notify the applicant of his/her admission or of the rejection of his/her application.

Article 14, para. 14.4 provides that, where the documentation submitted in view of participating the market is incomplete or irregular, GME shall – under the modalities and within the time limits defined in the Technical Rules – communicate to the applicant the steps necessary to complete or regularise such same documentation, as well as the date by which he/she shall do so.

Article 20, para. 20.1 provides that, for the purposes of exclusion from the market, Market Participants shall – under the modalities and within the time limits defined in the Technical Rules – provide GME with an appropriate written request.

1. Modalities and time limits of GME’s notifications

GME will notify by registered letter with return receipt, preceded by a fax:

- the admission of the applicant to the market or the rejection of his/her market participation application (article 14, para. 14.1);
- in the case of incomplete or irregular documentation, the steps necessary to complete or regularise such documentation, as well as the time limit by which the applicant shall do so (article 14, para. 14.4).

2. Modalities and time limits of the applicant/Market Participant's notifications (admission to/exclusion from the market)

A party applying for participation in the market must send to GME by ordinary mail or courier:

- one original copy of the market participation application, in the format of Annex 1 to the Electricity Market Rules, signed by the legal representative of his/her company (article 12, para. 12.1 a));
- one original copy of the documentation referred to in article 13 of the Electricity Market Rules, signed by the legal representative of his/her company (article 12, para. 12.1 a));
- two original copies of the market participation agreement, in the format of Annex 2 to the Electricity Market Rules, initialled on each page and signed at the foot by the legal representative of his/her company (article 12, para. 12.1 b));
- one original copy of the request for exclusion from the market, signed by the legal representative of his/her company (article 20, para. 20.1).
