

Technical Rule no. 6 Rev. 03 P-GAS

(under article 4 of the Regulations of the platform for the trading of bids/offers of natural gas, approved by the Ministry of Economic Development on 23 April 2010, as subsequently amended and supplemented)

1. Foreword

Article 18, para. 18.1 of the P-GAS Regulations provides that, in order to acquire the status of selling Participant in one or more Segments under Article 17, para. 17.2 e) of the P-GAS Regulations, the Participant shall - under the modalities and within the time limits defined in the Technical Rules - submit the terms and conditions of supply applicable to the above Segments to GME, specifying - among others - the Segment and the products to which the terms and conditions of supply refer.

Article 18, para. 18.2 of the P-GAS Regulations stipulates that, if the Participant has already acquired the status of selling Participant in one or more Segments of the P-GAS and intends to acquire the status of selling Participant also in the remaining Segments, he/she/it shall submit the terms and conditions of supply applicable to the above-mentioned remaining Segments to GME under the modalities and within the time limits defined in the Technical Rules.

Article 18, para. 18.6 of the P-GAS Regulations provides that, if the selling Participant intends to change the terms and conditions of supply with respect to those previously sent to and published by GME, he/she/it shall notify GME thereof by sending the new terms and conditions of supply to GME, under the procedures and within the time limits indicated in the Technical Rules.

2. Procedure and time limits to notify GME of the terms and conditions of supply (Article 18, paras. 18.1 and 18.2)

The terms and conditions of supply, duly signed by the legal representative of the Participant or by other duly authorised person, shall be sent to GME by ordinary mail or courier or by CEM. The terms and conditions of supply shall be accompanied by the “Lettera di trasmissione delle condizioni di fornitura” (letter of transmission of terms and conditions of supply), issued as per the form enclosed hereto and duly completed and signed by the legal representative.

GME shall publish the terms and conditions of supply on its website within five working days of receipt thereof and, within the same time limit, it shall prepare the order book or the auction of the selling Participant.

3. Procedure and time limits to change the terms and conditions of supply (Article 18, para. 18.6)

If the selling Participant intends to change the terms and conditions of supply with respect to those previously sent to and published by GME, he/she/it shall send to GME - by ordinary mail or courier or by CEM:

- the new terms and conditions of supply, duly signed by his/her/its legal representative or other duly authorised person. The new terms and conditions of supply shall be accompanied by the "Lettera di trasmissione delle condizioni di fornitura" (letter of transmission of terms and conditions of supply), issued as per the form enclosed hereto and duly completed and signed by the legal representative.

GME will publish all the received documents on its website within five days of receipt thereof.
