1. INTRODUCTION

Article 6 of the Regulation of the Bulletin Board of long-term contracts for energy from renewable sources (hereinafter: Regulation) provides that access to GME's information system takes place through the Internet, according to the methods and terms defined in the Technical Rules, or through any additional methods provided therein.

Article 12, paragraph 12.1, of the Regulation provides that participants access the PPA BULLETIN BOARD through specific procedures, defined in the Technical Rules, aimed at guaranteeing the identification of participants and the authenticity and confidentiality of the operations carried out through the PPA BULLETIN BOARD itself.

2. ACCESS TO THE INFORMATION SYSTEM OF THE PPA BULLETIN BOARD

Access to the information system takes place through a personal identification system of usersparticipants implemented by means of *user id* and *password*.

For this purpose, following the attribution of the status of operator of the PPA BULLETIN BOARD, GME will send each user indicated in the application for admission the credentials (*user id* and *first access password*) necessary for access to the information system.

Sending takes place by e-mail to the address of the user indicated in the application for admission to the platform.

Once the user has entered the credentials received from GME into the information system and clicked on the access button, the information system itself sends the user via text message to the user's mobile number indicated in the admission application, as possibly subsequently amended, a temporary access code, inserted which, by clicking on the SEND button, it will allow access to the information system of the PPA Bulletin Board.

After the first access, the user will have to modify the *password* sent by GME through the specific function on the platform.

The login credentials (*user id* and *password*) of the user must be saved, stored and kept confidential by the user themselves. For each subsequent access, the user must therefore:

connect to the GME website (<u>www.mercatoelettrico.org</u>)
access the "Markets" section on the home page
scroll the menu on the left to the bottom and select 'Electric Markets' /'PPA Bulletin
Board '/'access to the Platform'
insert user id and password and click on the login button.

Once the afore-mentioned activities have been completed, GME's information system will send the user, via text message, to the user's mobile number, a <u>temporary access code</u>, entered which, by clicking on the SEND button, it will allow access to the information system of the PPA Bulletin Board.

If the operator of the PPA BULLETIN BOARD intends to disable, add new users or modify the authorisation of users on the platform, they must submit or send to GME, by ordinary mail, courier or certified e-mail, an appropriate request, signed by the legal representative.

This request must be drawn up according to the "Request for management of PPA Bulletin Board users" form available in the "Electricity Markets/PPA Bulletin Board/How to participate/Forms" section of the GME website www.mercatoelettrico.org.

The information system of the PPA Bulletin Board provides for the recovery of credentials (*user id* and/or *password*) of the user. The credentials can be recovered through the specific functions made available on the platform.
