

Technical Rule no. 07 MLF

(pursuant to article 4 of the local flexibility market Regulations, approved by the Regulatory Authority for Energy, Networks and the Environment with resolution 372/2023/R/eel)

1. Introduction

Article 26, paragraph 26.2 of the Regulations provides that - if GME is unable to receive offers sent by Market Participants as well as by the DSOs, i.e. it is unable to receive from each DSO the preliminary data and information functional to the performance of the MLF sessions - GME notifies the Market Participants and each DSO, according to the methods defined in the Technical Rules, of the occurrence of the emergency condition as well as the new MLF trading session date, defined in agreement with the DSOs. If within the new date for the opening of the trading session the emergency condition persists, GME proceeds with the temporary suspension of transactions in the market.

Article 26, paragraph 26.3, of the Regulations provides that - if GME is unable to determine the results relating to a market session, or is unable to communicate to Market Participants and to DSOs, the results relating to a market session also due to malfunctions in GME information system or telecommunications systems - it suspends transactions in the MLF and informs the Market Participants and the DSOs of the occurrence of the emergency condition according to the methods defined in the Technical Rules,

Article 26, paragraph 26.4, of the Regulations provides that - if GME receives from the DSO, with respect to the related trading books, a specific request to cancel, or to suspend or to revoke the session held or in progress - GME communicates to the Market Participants, according to the methods indicated in the Technical Rules, the occurrence of the emergency condition, as well as, when applicable, the duration of the emergency condition.

2. Methods for communicating emergency conditions

If GME is unable to receive offers sent by Market Participants as well as by DSOs, or is unable to receive from each DSO the preliminary data and information functional to the performance of the MLF sessions, GME electronically, in accordance with the provisions of Article 9, paragraph 9.1, of the Regulations shall communicate to the Market Participants the occurrence of such circumstances, as well as the new date for the opening of the trading session. If, within the new session opening date the afore-mentioned malfunctions persist, GME will suspend the session and will notify the Market Participants of this circumstance, in accordance with the provisions of Article 9, paragraph 9.1, of the Regulations. In such cases, GME communicates the emergency condition to the DSOs in accordance with the provisions between GME and each DSO in the relevant Agreement defined pursuant to Article 15 of the Regulations.

If GME is unable to determine the results relating to a market session, or is unable to communicate the results relating to a market session to Market Participants and to DSOs, also due to malfunctions in GME information system or to telecommunications systems, GME shall notify Market Participants of such circumstances, electronically, in accordance with the provisions of Article 9, paragraph 9.1, of the Regulations. In such cases, GME communicates the emergency condition to the DSOs in accordance with the provisions between GME and each DSO in the relevant Agreement drafted pursuant to Article 15 of the Regulations.

If GME receives from the DSO, in relation to the relevant trading books, a specific request to cancel, or to suspend or to revoke the session held or in progress, GME electronically, in accordance with the provisions of Article 9, paragraph 9.1, of the Regulations, shall communicate to Market Participants the occurrence of the emergency condition, as well as, when applicable, the duration of the emergency condition.
