

**Technical Rule no. 03 Rev. 03 P-GO**

(under article 4 of the Rules governing the regulated market and the platform for registering bilaterals of guarantees of origin, successfully verified by the Director of Markets of *Autorità di Regolazione per Energia Reti e Ambiente* – ARERA – on 22 December 2011, as subsequently amended and supplemented)

<b>Title</b>	<b>Guarantee system for buy orders in the M-GO, guarantee system for requests of registration with technical adequacy verification on the PB-GO, and emergency conditions in the P-GO</b>

## 1. Foreword

Article 40, para. 40.2 of the “Rules governing the regulated market and the platform for registering bilaterals of guarantees of origin” (hereafter P-GO Rules) provides that, in the case referred to in the previous para. 40.1 a), GME shall - under the modalities indicated in the Technical Rules - notify Participants of the occurrence of the emergency condition and of the new opening time of the session of the M-GO or of the PB-GO. If, by the new opening time of the session of the M-GO or of the PB-GO, the emergency condition persists, GME shall temporarily suspend transactions in the M-GO or on the PB-GO.

Article 40, para. 40.3 of the P-GO Rules provides that, in the cases referred to in previous para. 40.1 b) and c), GME shall suspend transactions in the M-GO or on the PB-GO and notify Participants – under the modalities indicated in the Technical Rules – of the occurrence of the emergency condition.

Article 42, para. 42.1 of the P-GO Rules that a Participant wishing to enter buy orders into the M-GO shall make an interest-bearing deposit into the designated account of GME and notify GME of the amount thereof in accordance with the modalities and within the time limits established in the Technical Rules.

Article 42, para. 42.2 stipulates that, during the M-GO session, the Participant may increase the deposit covered by para. 42.1, by making an additional deposit into the designated account of GME, in accordance with the modalities and within the time limits defined in the Technical Rules, and notifying GME of the amount thereof. The payment shall have effect within one hour of the time at which it has been credited to GME’s bank account. The payment shall be deemed to have been received on the date and at the time recorded by the information system of the bank in charge of GME’s treasury services. GME shall update the deposit by an amount equal to the additional payment made.

Article 42, para. 42.3 stipulates that, if the Participant takes part in the M-GO through multiple access profiles, he/she/it may - under the procedures and within the time limits established in the Technical Rules - allocate the amount of the deposit mentioned in para. 42.1, as

possibly increased under para. 42.2, among the above profiles. Failing indications about the allocation of the deposit, GME shall proceed in accordance with the modalities set out in the Technical Rules.

Article 43, para. 43.8 provides that, without prejudice to the provisions of article 51 of the P-GO Rules, GME shall refund the amount of the available deposit under the procedures and within the time limits defined in the Technical Rules.

Article 46, para. 46.2 provides that, for requests of registration of bilateral transactions with technical adequacy verification (art. 32, para. 32.4 b), the buying Participant shall make an interest-bearing deposit into the designated account of GME, in accordance with the modalities and within the time limits defined in the Technical Rules, and notify GME of the amount thereof.

Under para. 46.3, if the buying Participant takes part in the PB-GO through multiple access profiles, he/she/it may - in accordance with the procedures and within the time limits defined in the Technical Rules - allocate the amount of the deposit referred to in para. 46.2 among the above profiles. Failing indications about the allocation, GME shall proceed as established in the Technical Rules.

Article 47, para. 47.1 provides that a request for registration of bilateral transactions is guaranteed under the previous Article 34 if the value of the accepted request for registration (increased by VAT, where applicable) is lower than or equal to the amount of the security deposit referred to in article 46 above, possibly :

- a) increased by the value of the concluded bilateral transactions of sale as per article 32, para. 32.4 b), except as provided in the Technical Rules; and/or
- b) decreased by the value of the concluded bilateral transactions of purchase as per article 32, para. 32.4 b).


Article 53, para. 53.1 provides that, with regard to the requests for registration with technical adequacy verification pursuant to article 32, para. 32.4 b), GME shall – within the time limits indicated in the Technical Rules – make the payment for each concluded registration to the selling Participant, by using the buying Participant’s available deposit referred to in article 46.

Para. 53.2 stipulates that, at the end of the payments mentioned in para. 53.1, GME shall - under the procedures and within the time limits indicated in the Technical Rules - refund the residual amount (if positive) of the security deposit referred to in article 46 to the buying Participant, unless otherwise specified by the same Participant in accordance with the modalities and within the time limits established in the Technical Rules.

## 2. Finance management in the M-GO

To access the finance management page, select the “Sessioni di mercato” (market sessions) link available at [www.mercatoelettrico.org](http://www.mercatoelettrico.org), in the “The Markets/Access to GME’s markets”/P-GO/Access to the P-GO” section and enter your “**ID\_Profilo**” (profile ID) and the related **password**. After access, by clicking on “**Gestione finanze**” (finance management), you will get the following form:

In the upper right part of the form (Figure 1), you will see the “**Deposito operativo**” (operational deposit) pertaining to the access profile that you wish to use for making purchases during the market session.

## 2.1 Notification of the initial deposit for participation in the M-GO

Based on the provisions of the Rules, a Participant wishing to purchase in the M-GO must make an initial interest-bearing deposit (by bank transfer) into the designated account of GME. The deposit must be available by 12:00 of the working day before the one of the market session (with value date on the same day); by the same time limit, the Participant must also notify the amount of the deposit on the platform.

The deposit must cover the total value of purchases, including VAT (where applicable).

To notify the payment, use the “Gestione Finanze” (finance management) form (Figure 1).

In the “**Richiesta notifica nuovo deposito**” (request of notification of new deposit) field, specify the amount (in euro and cents of euro) of the payment and click on the



(submit request) button.

If a Participant wishes to operate through multiple access profiles (each associated with each of the different GO ownership accounts that he/she/it holds) and to allocate the amount of the deposit among the different profiles, he/she/it must notify - by accessing the system through the respective profiles - the share of the amount of the bank transfer to be used for participating in the market session through each operating profile. If the Participant fails to give the above notifications or if the notifications given through the different profiles are incomplete and/or do not match the amount paid by the Participant (e.g. the amount paid is higher/lower than the total of the amounts specified for the individual profiles), GME will share the received amount in equal parts among all the profiles.

The notifications of deposits awaiting validation by GME are listed in the “**Richieste in attesa di validazione**” (requests awaiting validation) section.

After verifying the actual availability of the notified amounts on its account, GME will accept or reject the request.

## 2.2 Notification of the additional deposit

A Participant may increase his/her/its initial deposit during the market session, by making a payment (by bank transfer) into the designated account of GME, with value date on the same day, notifying GME thereof by sending an e-mail to [go@mercatoelettrico.org](mailto:go@mercatoelettrico.org) and notifying the amount thereof in the “Gestione Finanze” (finance management) section (para. 2.1) in due time before the closing of the session. If the same Participant is operating in the market through multiple profiles, GME will share the received amount in equal parts among all the profiles, unless the Participant has specified the allocation of the additional deposit, notifying the amount/amounts for each profile on the platform.

GME will accept the request within one hour of the time at which the payment has been credited to its designated bank account.


## 2.3 Request of refund of the available deposit at the end of the M-GO session

At the end of the market session, the system will automatically refund the entire deposit. If the Participant wishes to keep the available deposit on the account through which he/she/it has operated, in order to use it in the subsequent market session, he/she/it must select the “**Mantieni intero deposito**” (keep entire deposit) option (Figure 1), which will remain highlighted in the subsequent market sessions until new notice. If, instead, the Participant wishes to receive the partial refund of the deposit, he/she/it may select the “**Rimborsa un importo pari a**” (refund an amount of) option (Figure 2) and specify the amount to be refunded in the appropriate window. If the deposit available upon the closing of the session is lower than the specified amount, GME will refund the entire deposit.

At the end of the session, GME will refund the entire or residual deposit by bank transfer, with value date on the working day following the one of the session, to the bank account specified by the Participant upon registration with the electronic market platform.

If the same Participant has used multiple profiles to operate in the market, he/she/it must specify the details for the possible refund of the deposit for each profile, making notifications on the platform as indicated above.

### 3. Deposit management on the PB-GO for registration of bilateral transactions with technical adequacy verification

To access the finance management page of the platform for registration of bilateral transactions, available at [www.mercatoelettrico.org](http://www.mercatoelettrico.org), in the “The Markets/Access to GME’s Markets/P-GO/Access to the P-GO” section, enter your **ID\_Profilo** (profile ID) and the related **password**. After access, by clicking on “**Gestione finanze**” (finance management), you will open the following form:




In the upper right part of the form, you will see the “**Deposito operativo**” (operational deposit) pertaining to the access profile that you wish to use for making purchase registrations on the PB-GO.

Bilateral transactions with technical adequacy verification are validated by GME on the day before each GO market session.

If a Participant has been designated as buying counterparty to a bilateral transaction with technical adequacy verification on the PB-GO, he/she/it must make an interest-bearing deposit (by bank transfer) into the designated account of GME. The deposit must be available by 12:00 of the working day before the market session (with value date on the same day); by the same time limit, the Participant must also notify the amount of the payment on the platform.

The deposit must cover the total value of purchases for which registration is requested, including VAT (where applicable).

The Participant must notify the payment through his/her/its operating profile, by using the appropriate form on the right side of the screen (Figure 3).

In the “**Richiesta notifica nuovo deposito**” (request of notification of new deposit), specify the amount (in euro and cents of euro) of the payment and then submit the notification by clicking on the  (submit request) button.

If a Participant wishes to operate through multiple access profiles (each associated with each of the different GO ownership accounts that he/she/it holds) and to allocate the amount of the deposit among the different profiles, he/she/it must notify – using the respective access profiles – the share of the bank transfer to be used for purchases on the PB-GO through each access profile. If the Participant fails to give the above notifications or if the notifications given through the different profiles are incomplete or do not match the amount paid (e.g. the amount paid is higher than the total of the amounts specified by the individual users), GME will share the received amount in equal parts among all the profiles associated with the Participant.

The notifications of deposits awaiting validation by GME are listed in the “**Richieste in attesa di validazione**” (requests awaiting validation) section.

After verifying the actual availability of the notified amounts (guaranteeing the payment for the purchase of GOs) on its account, GME will accept and/or reject the request.

For the purposes of acceptance of bilateral transactions with technical adequacy verification, GME will ensure that the value of the request for registration accepted by the buyer (increased by VAT, where applicable) is lower than or equal to the amount of the security deposit, as possibly

- a) increased by the value of concluded bilateral transactions of sale with technical adequacy verification, and/or
- b) decreased by the value of concluded bilateral transactions of purchase with technical adequacy verification.

If the selling Participant is registered also with the M-GO, the amount of the bilateral sale will be made available on his/her/its budget for participation in the M-GO session to be held on the following working day.

### **3.1 Management of payments for bilateral transactions with technical adequacy verification and buying counterparties that qualify as non-PA Participants**

GME will make payments on behalf of non-PA buying Participants. For each registration completed, within 24 hours of the closing of a session of the GO market, GME will make the payment to the selling Participant, by using the available deposit of the buying Participant, with value date on the second working day following that on which the registration has been completed.

### **3.2 Management of payments for bilateral transactions with technical adequacy verification and buying counterparties that qualify as PA Participants**

GME will make payments on behalf of PA buying Participants. GME will make the payment, by using the available the deposit of the buying Participant, as soon as it receives confirmation both from the Italian selling Participant and the PA Participant of the delivery

and receipt of the electronic invoice, respectively, as provided by Law 244/2007 and its implementing provisions, and as specified in Technical Rule 02 P-GO.

The payment on behalf of the PA Participant will be made by GME with value date on the working day following the one of the first market session that will be held starting from the date of receipt of the latest of the above confirmations.

Conversely, if GME receives confirmation only from the Italian selling Participant or only from the PA buying Participant, it will proceed as follows:

- if the confirmation is given only by the Italian selling Participant, GME will make the payment fifteen days after the date of such partial confirmation, provided that it has received appropriate documentation from the Italian selling Participant certifying the completion of the process as per Law 244/2007 and its implementing provisions. In this case, GME will make the payment on behalf of the PA Participant with value date on the working day following the first market session after the aforementioned period of fifteen days. If GME does not receive appropriate documentation confirming the completion of the process as per Law 244/2007 and its implementing provisions, GME will cancel the registration fifteen days after the confirmation made by the Italian selling Participant;
- if the confirmation is given only by the PA buying Participant, GME will make the payment fifteen days after the date of such partial confirmation, with value date on the working day following the first market session after said period of fifteen days.

It is understood that GME will cancel the registration if, fifteen days after the acceptance of the request for registration by the buying Participant, neither of the two parties has provided confirmation of the successful delivery/receipt of the electronic invoice.

GME will ensure, however, the coverage of the value of the transactions by blocking the deposit of the PA buying Participant for an equal amount ("deposito bloccato per transazioni bilaterali" – deposit blocked for bilateral transactions – in the "gestione finanze" – finance management - section).



If the Participant wishes the partial refund of the deposit, he/she/it may select the “**Rimborsa un importo pari a**” (refund an amount of) option (Figure 4), specifying the amount to be refunded in the appropriate window. If the deposit available upon the closing of the session is lower than the specified amount, GME will refund the entire deposit.

### 3.4 Request of change of IBAN code

To notify the change of the IBAN code entered upon registration of the Participant with the platform, the Participant must send a notification (on letterheaded paper of the company and signed by its legal representative) to the “Amministrazione, Finanza e Controllo” (Administration, Finance and Control) Department of GME.

**4. Emergency conditions**

If emergency conditions arise, as provided in article 40 of the P-GO Rules, GME will immediately notify users thereof by e-mail.
